News from the voluntary return field and migration in Europe

- Europe:** RIAT will get faster next year! RIAT 2.0 will run on a new server independent from the European Commission starting from the beginning of 2024; watch out for more information from your national authority about possible new log-ins or creating new accounts.
- Germany:** Heavy deportations of Iraqi citizens without legal permission to stay started in the 2. half of 2023, after a migration cooperation agreement between the German and Iraqi government was signed in spring 2023. Hence, a lot more Iraqis are considering voluntary return and are seeking counselling.
- Germany:** The AVRR counselling system is decentralized in Germany and carried out by various actors (NGOs, IOM and the government). IOM has had, however, the only mandate in Germany to implement the federal program for the financial and logistical AVRR assistance (hence booking plane tickets and disbursing money) for more than 20 years. From January 2024, the Federal Office for Migration and Refugees (BAMF) will take over this mandate; transition problems can be expected which might delay voluntary returns in the first quarter of 2024.
- Portugal:** The Immigration and Border Services (SEF) closed on 29.10.2023 with the goal to create a separation between the border police and immigration & asylum authority. The newly created Agency for Integration Migration and Asylum (AIMA) is in charge of asylum now.
- Belgium:** The “reception crisis” is climaxing with currently around 5000 single young male asylum seekers forced to sleep in the streets because the government has run out of accommodation places for asylum seekers.

Reinventing your future

I sometimes feel so inspired by the attitude people have towards life, work and challenges. A Swiss AVRR counsellor, who I met during one of the Transnational Exchange VI activities, started her professional career in the investment field – dealing with huge amounts of money and living in countries like Japan and Singapore.

After some years, she felt the urge to change careers in her early thirties and got a second masters in International cooperation and development. By chance, she took her first job after graduation in 2016 as an AVRR counselor for an NGO. She has loved it ever since.

She observes the changes in Europe in the voluntary return field with great interest and curiosity. More and more governments want to be in charge of AVRR counselling alone which creates sorrows and concerns about the future for many NGO AVRR counsellors. Instead of being downcast and scared about future developments for NGOs, this lady sees opportunities for NGOs to reinvent its work and to scout new fields of services.

This positive excitement towards change and little fear of losing the old and familiar is admirable. It's one thing to talk about welcoming change but it's another thing to actually go through with it with a positive attitude. She talks the talk and walks the walk. That's why I am inspired!

HOWEVER, I don't think it is wise for governments to exclude NGOs from the AVRR counselling field. A complementary coexistence would cater best to the migrants' needs. -Salomé
